Where our pupils travel from	<p>St Joseph's is located at the top of a cul-de-sac, Rosebank, which leads off from West Street. Rosebank is heavily congested at peak times because parking bays reduce the road to single lane traffic in many sections with limited visibility in parts. There is very little turning room.</p> <p>At the foot of Rosebank there are traffic lights. The junction is busy and the main road adjoining Rosebank leads on to the Epsom one-way system.</p>

Working Group Actions

September 2018: A new gate was opened on the perimeter to facilitate access to the school from Whitehorse Drive. This provided a more efficient route to school for those families arriving from Langley Vale, Epsom Downs and Ashted (61 families in February 2019 survey). The gate area is fully supervised, providing parents with a safe 'drop and go' option. In February 2019, we measured 130-150 children using this route each morning.

September 2018: Easy pick up arranged at a supervised gate. This allows parents, who needs to drive in from our outlying areas, to drive by and pick up.

October 2018: Change to the start of the school day for years R and 1. This allowed parents to 'drop and go' from 8.40am, significantly reducing the number of parents attempting to park around the school.

December 2018 onwards: Early access to classrooms provided for years 2 and 3. In total this means that 240 children may now arrive early, discouraging their parents from parking in the local area.

March 2019: A petition was heard at Epsom and Ewell local committee meeting requesting that parking restrictions be changed on the roads on Abelea Green at school pick up and drop off times. These empty roads would provide a calm zone for parking and walking children to school with the added advantage that the children would not have to cross any roads to access the school.

April 2019: Extensive investigations established that running minibuses from Langley Vale and other outlying areas are cost prohibitive to families. Meetings with SCC about Walking Buses came to no conclusion, as appropriate sites were not obvious to officers. However, we remain open to officers' ideas and support.

January 2020: Early access to classrooms for the rest of the school. There is now very little congestion on Rosebank due to the changes we have made.

January 2022 after school club survey: Typically about 40% of all children stay until 4.00pm. This provision ensures a staggered departure on Rosebank, thereby reducing congestion.

How many volunteers have been involved supporting the school travel plan work/ initiatives, this year?

Governors and senior staff have been central to the delivery of the Travel Plan. A good number of the parent body have been committed to delivering aspects of the Travel Plan. We have and continue to work closer with Surrey County Council Officers to develop appropriate, safe and workable solutions to any problems. We have engaged with Borough and Surrey County Councillors. Residents are in regular communication with the school about access and their views have been fully considered when developing policies and procedures. The Working Party remain committed to identifying safe access to school keeping central to all decisions the impact on the local community.

Details of coach parking facilities	<p>Access to the school is significantly limited by the single lane route in the section of the road just outside the school. This coupled with a tight entrance to the car park renders it almost impossible for a coach to gain access.</p> <p>The daily school bus has to wait half way down Rosebank, about 300m from the school. This is the same for any school trips which require a coach.</p>	

Transportation Links

Buses*	School bus provided by Edward Thomas Ltd. An historic relationship with the company ensures that they nowadays run a public bus which follows a previous route designed specifically for the school. While students from other schools use the bus, the route begins and ends at St Joseph's on Rosebank. A copy of the route is available from the school office. The bus will take children to Ewell and Worcester Park. The school actively and regularly promotes its use and we have seen a steady increase in use since Sept 2019.
Rail*	Epsom railway station is about 5 minutes walk from the school. It could potentially transport children from Ashted and Ewell but parents are deterred by the daily cost.
Roads*	All access to the school is via Rosebank which is narrow, with parking on one side for much of its length. Rosebank is a cul-de-sac. It leads off from West Hill.
Walking Routes*	The school can be accessed via Rosebank and via Whitehorse Drive.
Cycling Routes*	The school can be accessed via Rosebank and via Whitehorse Drive. There are no designated cycle paths accessing the school.

Pedestrians are required to cross at least two roads on Rosebank en route to the main road. While the side roads are fairly quiet, Rosebank is ill equipped for pedestrians as it lacks a safe crossing place.

Current Travel & Transport Issues			
Parking	Since October 2018, an historic pedestrian access point and 50 space car park, adjacent to the school has been closed. This has placed significant pressure on the now only road access to the school and the residents living in the area. Working with Surrey Highways we have been investigating possibilities within the vicinity of places where parents can park and stride with their children to and from school.	We anticipated the problems in advance of the route closure and governors planned accordingly as far as was possible to alleviate the new pressures.	Local Councillors are considering a proposal to provide a few more parking spaces at drop off and pick up times within safe walking distance of the school. The school continues to strongly encourage parents to use green travel and avoid driving to school. It would be safer for the children if the former access route was reopened.
